Forrester Park will be a "controller" of the personal information that you provide to us [in this form / through this website, etc.] [unless otherwise stated].

Members' personal data: we will only use for legitimate business needs.

When you register as a member of Forrester Park or renew your membership (including if you are registering or renewing on behalf of a child under the age of 18), we will ask you for the following personal information:

- Provide competition in golf by accepting and managing entries for our competitions and checking your personal information to ensure you
  are entered into the correct category.
- Monitor and develop participation in golf by monitoring members' engagement and participation through entries and inviting our members
  to participate in surveys for researching and development purposes.
- If you believe that any of your personal information is inaccurate or incomplete, you have a right to request that we correct or complete
  your personal information.
- You have a right to request that we restrict the processing of your personal information for specific purposes.
- If you wish us to delete your personal information, you may request that we do so.

We publish the results of our competitions on our website. This includes competitors' name, result].

### Who we share your personal information withii

If your personal information is included in any images or videos taken by us at our competitions and events, we may share this with SGU and PGA for promotional and/or journalistic purposes.

We may be required to share personal information with statutory or regulatory authorities and organisations to comply with statutory obligations. Such organisations include the Health

& Safety Executive, Disclosure Scotland, and Police Scotland for the purposes of safeguarding children

In the event that we do share personal information with external third parties, we will only share such personal information strictly required for the specific purposes and take reasonable steps to ensure that recipients shall only process the disclosed personal information in accordance with those purposes.

As an affiliated club of the Scottish Golf Union we are required to ensure that all of our competition members are members of the Scottish Golf Union as a condition of our membership affiliation.

We may also share personal information with our professional and legal advisors for the purposes of taking advice.

We will share your personal data with the Scottish Golf Union who will become a controller of your personal information when they receive it.
